**SUMMARY:** The Westport Business and Commerce Collection contains articles, brochures, invoices, correspondence, advertisements, deeds, and other documentation relating to Westport companies and commerce activities, including manufacturing, agriculture, shell fishing, mills, shipping, and the Westport Bar Association.

#### **HISTORICAL NOTE:**

Westport had a navigable river and several streams that could be dammed to produce waterpower in the early days of its history. Grist and saw mills dotted the banks. Ocean-going ships could sail up to warehouses and docks to transport farmers' products to other coastal communities as well as to the West Indies. When farming became specialized, Westport onions were shipped to New York City, to the benefit of several local families as well as the middlemen – the captains of the packet boats. Detailed ships' logs in this collection document the cargos and financial transactions of various types of boats sailing out of Westport.

The railroad, completed through town in 1848, gradually replaced the market boats. Saugatuck became a favored area for factories and manufacturing concerns extended as far northward as the Richmondville area of the town. The riverbanks continued to be attractive to small industries for their access to shipping and old-fashioned, but still useful, waterpower. The introduction of steam power brought about the almost complete transfer of manufacturing from rural areas to the southwestern coastal area by the end of the 19<sup>th</sup> century. Except for the fuel industry and small-scale lumber companies, few of Westport's early enterprises still exist.

Among the notable individuals and families involved in business and commerce in Westport are the following:

John S. Jones was editor and publisher of the *Westporter-Herald* and author of the manuscript "Reminiscent Westport." In 1860 he was the Chief Officer of the all-volunteer Compo Engine Company #2.

Charles H. Kemper came from Hudson, NY to manage a tannery that he bought in 1866. At one time he employed 100 men, conducting his business in the brick building on Riverside that became headquarters for the MCA Company in the 1980s. He was a selectman in 1882.

B. H. Toquet was a prolific inventor of mechanical devices. He produced carburetors for Ford motor cars. The business was continued by his son, B. Louis Toquet, who married Nellie Bradley, granddaughter of Morris Bradley, purchaser in 1865 of Wheeler House.

The Nash family bought their mill after the Revolutionary War when they returned from Long Island where they had fled as Tories. The family proved to be resourceful proprietors, turning to ice harvesting when the grist mill business declined.

The Dorr Mill, which was originally a grist mill, was converted to a textile mill and reconverted to grinding grains when the textile industry failed locally. Dorr operated a chemical laboratory at this location and the Embalmers' Supply Company and Glendinning Corporation were subsequent owners.

Other important manufacturing businesses in town included the Baynham Coffin Tack factory and the Saugatuck Manufacturing Co., which was established in 1837 by E. S. Wheeler for the manufacture of cloth-covered buttons and lining tacks for the casket trade.

Agriculture played a significant role in the life of Westport from the time of the first settlers until the 20<sup>th</sup> century. The first white settlers farmed to feed their own families and livestock, but by the end of the 18<sup>th</sup> century, residents on the east side of the Saugatuck River were growing onions for market. By the middle of the 19<sup>th</sup> century onion production was flourishing and the "Southport Globe Onion" was grown and widely sold. Wharves, warehouses, and a tavern were established on the west side of the Saugatuck River to serve the ships that were traveling down river to carry onions to market. After the Civil War, onion production began to decline. Labor shortages, disease and the rise of real estate values all contributed to this decline. By the end of the 19<sup>th</sup> century, onion farming had virtually disappeared as farmers to the production of other crops for local markets. With the post-World War II housing boom, land became too valuable to be set aside for farming and the last of the big working farms shut down.

#### **SCOPE AND CONTENT**

The collection is divided into five series. Photographs have been separated from the collection and are stored in Record Group 13. See also Record Group 8 for additional personal papers of some of the individuals and family represented in this collection.

Series 1 contains general historical background and a set of vintage advertisements for Westport businesses. An essay by Barbara Raymond, "Westport Business & Industry" provides an overview for the collection.

Series 2 provides documentation of specific companies, alphabetically listed. Documentation for the John S. Jones Company includes advertisements, letterheads, invoices, programs, etc. that were printed by the company. Documentation of the Charles H. Kemper Company includes letters, advertisements, and a ledger of the "Charles H. Kemper Hot Leather Works." Documentation for the Lees Manufacturing Company includes land deeds as well as minutes of a meeting of the Saugatuck Manufacturing Company (its original name.) Documentation of the Toquet Company includes business letters, invoices, and patent information. The company made marine motors at Saugatuck near the railroad station and had an office at Metropolitan Building in New York City. A number of blueprints are stored with Oversize material. Documentation of Westport Bank & Trust dates from 1860 to 1984. The bank was formed from 1st National Bank of Westport and Westport Savings Bank in 1913 and acquired by Lafayette American Bank in 1996.

Series 3 contains topically arranged documentation on Agriculture, Fishing/Shellfishing, and Mills/Manufacturing.

Series 4, Shipping Records, contains valuable detailed shipping logs for various boats, including the "James K. Polk" (1853-1880s), the "None Such" (1850-1852), the Lyman Jenison (1852), the "Sarah B. Bulkley" (1875), "Middletown" (1845-1846), and "Intrepid."

Records of the Westport Bar Association in Series 5 provide a snapshot of the activities of this organization in Westport during the 1970s and 1980s.
