Abstract:	This collection documents the Sherwood family that settled in the Westport, Connecticut area in the late 18th century. It includes correspondence, records related to the family's shipping business, personal financial records, legal documents, and genealogical and biographical information.

### **Historical Note**

The Sherwood family originally settled in Fairfield County from Ipswich, England in 1634. Samuel Sherwood (born around 1660) was the first miller of Southport. The Sherwood family acquired the Mill Pond gristmill in 1790, which serviced local farmers. The mill burned down in 1895. Sherwoods farmed on what is now Sherwood Island in Westport through most of the 1800s. Crops such as onions and potatoes were shipping to New York and oysters were harvested.

From Samuel Sherwood (b. ca 1660) descended Deacon Samuel (1699-1768), Reverend Samuel (1729-1783) and Honorable Samuel (1767-1833). Another son of the first Samuel

Sherwood was Daniel (1708-1784) whose grandson Daniel (1761-1828) built a homestead on what is now Sherwood Island and married Catherine Burr. The children of Daniel and Catherine Sherwood were: Gershom Burr Sherwood (1787-1795); Ebenezer Burr Sherwood (1788-1860); Catherine Sherwood Dimon (1790-1838); Eunice Sherwood Burr (1793-1864); Daniel Sherwood IV (1795-1878); Abigail Sherwood (1799-1799); Abraham Sherwood (1802-1873); Silas Burr Sherwood (1805-1861); Francis Sherwood (1810-1881); Franklin Sherwood (1810-1884); Frederick Sherwood (1810-1888)

Of the sons of Daniel Sherwood (1761-1828), Abraham Sherwood (1802-1873) became a merchant and ran a market boat to New York during the prosperous days of onion farming in Westport. Triplets Francis, Franklin, and Frederick were all sea captains. They looked very similar to each other and all lived in Westport when they were not out to sea. Captain Francis was shipwrecked on the Brig Ashley ini 1842 and in 1847 his ship Carolina brought dispatches to New Orleans announcing the surrender of Mexican forces. Captain Franklin was engaged in trading between New York, Havana, New Orleans, and Texas ports from 1835-1839. He later went to China, eastern ports, and European ports. Captain Frederick also traded in southern ports and made six voyages to California by the way of Cape Horn.

Other prominent Sherwood descendants included Henry Burr Sherwood who played a notable role in the 19th century economy of Westport. He owned the Compo Tide Mill and invented a farming implement that was important for the local onion-growing business.

# Scope and Content of Collection

This collection documents the Sherwood family that settled in the Westport area in the late 18th century. A large part of the documentation in this collection relates to the children of Daniel Sherwood (1761-1828) and Catherine Burr Sherwood (1766-1835). These children included seven sons who became prominent businessmen and sea captains. The collection is particularly valuable for the detailed records it contains related to the shipping business of the Sherwood sons, including triplet sea captain brothers Frederick, Francis, and Franklin Sherwood. The collection also contains extensive genealogical documentation related to the various branches of the Sherwood family.

Though fragmentary in nature, this Sherwood family collection includes important biographical documentation about the family and notable records of the shipping business they were involved in. Very detailed records for the ships Satira, Cordelia, and Carolina provide a window into the types of goods exchanged and situations encountered. Correspondence documents the trials and tribulations of the business. Also of note are two Revolutionary Era sermons of Samuel Sherwood dating from 1774 and 1776, very detailed personal financial accounts of various Sherwood family members, and numerous deeds that track the property transactions. The collection includes some early legal documents of the Bennitt/Bennett family, including the 1772 will of William Bennitt, which gives to his wife the "use and improvement" of two slaves. The Bennitts were related to the Sherwoods by marriage. Early photographs of family members and of a sailing vessel belong to Abraham Sherwood are contained in Series 6, Biographical Documentation, as well as extensive genealogical material.
